# Appendix 1 - Police overview report for Bilbrook Parish Council Dates: 03/12/2019 - 02/01/2020

Public bodies can only disclose information if they have the power to do so. Section 115 of the Crime and Disorder Act provides a power to exchange information where disclosure is necessary to support the local Crime Reduction Strategy and Partnership in achieving the aims of the Crime and Disorder Reduction Strategy and objectives outlined within it. The degree of disclosure that takes place must be proportionate and relevant to the level of social ill or criminality it is intended to counter or prevent. The information is only to be processed in relation to crime and disorder purposes. Information will be handled in accordance with the Data Protection Act 1998, the Human Rights Act 1998 and any other relevant legislation governing disclosures and will ultimately be disposed of in a secure manner.

#### Main headlines since the last meeting:

Anti-social behaviour: On 8th December, there was an organised car meet in and around Pendeford Mill Lane. Cars were reported to be racing one another and causing anti-social behaviour. All cars were checked out by officers and ordered to leave the area. No further issues reported.

Officers were called to a large house party on Brookfield Road on 21st December which was making its way into the street. On arrival, adults of the youngsters involved were at the scene and the party was shut down shortly after.

We have had reports that people's cars have been spat on along Wesley Road. No CCTV or lines of enquiries but have advised residents to install CCTV which covers their property and vehicles.

**Vehicle Crime:** - Number plates have been stolen from a vehicle on Brookfield Road. Unfortunately, there is no CCTV covering where the car was parked, however, a marker has been placed on the registration plates if they are used in crime in the foreseeable future.

**Burglary:** A house was broken into on Bilbrook Road during the early hours of 23rd December. Offender(s) searched the house seemingly looking for the keys of a parked BMW on the elderly ladies driveway. However, this was the next doors vehicle who was keeping it on her drive. Around £300 stolen from the ladies purse. Forensics have taken various DNA hits and the investigation is on-going.
