- c) Platinum Jubilee Working Party an update was given. The event will be scaled down and will be held on Bilbrook Village Green
- **d)** Remembrance Working Party <u>Matter of Report:</u> The event went very well. A procedure is to be put in place to stop groups from being missed off the wreath list. A PA system to be purchased for next year.
- e) Christmas Working Party <u>Matter of Report:</u> It was a successful evening which almost didn't go ahead due to the heavy rain in the morning and strong winds predicted. The bigger stage worked well. The parish council gazebo was destroyed by the wind, therefore, to consider hiring one next year. The parish council raised £339 for Codsall & Bilbrook Cancer Support.
- f) Neighbourhood Plan Steering Group An update was given on the Neighbourhood Plan Steering group. Resolved: To approve the Neighbourhood plan budget and apply for the 2nd grant.

a) Clerks Report – The Clerk's report was received and noted. (Appendix 4)

Local Plan Review – <u>Resolved:</u> A detailed response is being drafted to the proposal to build 848 new homes in Bilbrook. (Proposed site allocation 519) It will state that while Bilbrook Parish Council welcomes some new homes being built in Bilbrook, 848 new homes is not sustainable and not needed for the people of Bilbrook. The Parish Council believes the current plan

allocation of approx 267 dwellings on greenfield sites is more than adequate and the other 581 homes should not be built as they will go on Greenbelt.

Bilbrook Parish Councils objections are:

- The duty to co-operate with the West Midlands and provide 4,000 new homes means that Bilbrook greenbelt will be sacrificed to save West Midlands Greenbelt.
- The semi-rural nature of Bilbrook will be lost and it will become a small town.
- The land is very good quality agricultural land and should not be built on.
- The erosion of the Strategic Greenbelt between Bilbrook and Wolverhampton.
- Bilbrook should not be classed as a Tier 1 Settlement because it has a train station especially given there is no station car parking.
- There is insufficient infrastructure to support the development and the infrastructure suggested (a new first School and new retail development) is poorly evidenced and shows a lack of understanding of Bilbrook.
- The roads around the development have dangerous junctions that already cannot cope with the increased traffic from the new Pendeford Mill Lane development in Bilbrook and the Watery Lane development in Codsall.
- The loss of the natural environment and negative impact on Climate Change.

Appendix 2 – Police Report

Dates: 4th November – 27th November 2021

Public bodies can only disclose information if they have the power to do so. Section 115 of the Crime and Disorder Act provides a power to exchange information where disclosure is necessary to support the local Crime Reduction Strategy and Partnership in achieving the aims of the Crime and Disorder Reduction Strategy and objectives outlined within it. The degree of disclosure that takes place must be proportionate and relevant to the level of social ill or criminality it is intended to counter or prevent.

The information is only to be processed in relation to crime and disorder purposes. Information will be handled in accordance with the Data Protection Act 1998, the Human Rights Act 1998 and any other relevant legislation governing disclosures and will ultimately be disposed of in a secure manner.

Main headlines since the last meeting

- Crime: There has been a couple of burglary businesses, Wobaston Road and Valiant Way. A burglary residential has occurred in Acacia Crescent, a couple of reports of criminal damage one at a garage in Brookfield Road and one to a vehicle on Bilbrook Road.
- ASB: A report of anti-social behaviour/verbal abuse at an address in Heath Farm Road. An incident between parents at school on Bilbrook Road and one youth-related incident on Lime Tree Gardens, where High School youths are throwing things at a house next to the alleyway there.

DISTRICT REPORT DECEMBER 2021 Gary Burnett

• NEW WARDING PATTERN FOR SOUTH STAFFORDSHIRE – DRAFT RECOMMENDATIONS FOR PUBLIC CONSULTATION - The Local Government Boundary Commission for England have now published their draft recommendations, proposing that South Staffordshire District Council should have 42 councillors, a decrease of seven from the existing arrangements. Those councillors should represent 6 three-councillor wards, 10 two - councillor wards and 4 one-councillor wards across the council area. The boundaries of three wards (Essington, Himley & Swindon and Huntington & Hatherton will stay the same, all others should change).

Before drawing up the draft recommendations, the Commission carried out a public consultation inviting proposals for a new pattern of wards for South Staffordshire. They have considered all the submissions that they have received during that phase of consultation.

- BILBROOK HOUSE Staffordshire County Council has applied for and obtained a demolition order for the demolition of Bilbrook House on Carter Avenue. The work has recently begun with the contractors drilling exploratory holes into the outside of the building to assess the type of construction materials used.
- NEW HOUSES ON GARAGE SITE OFF LIME TREE ROAD. Housing Plus are well underway with the
 development plans for the above site. The winning contractor is Hawk Developments and they anticipate commencing on site in December 2021. This will allow Housing Plus plenty of time to claim
 the grant from South Staffordshire Council before the deadline of March 2023.
