### b) South Staffs District Council - by District Cllr G Burnett.

- District Councillors will be meeting Bloor to discuss the new development.
- Local Plan 860 houses has come down to 750. A Parish Council response is to be drafted.
- There is no update on the plans for the site of the old Bilbrook House.

### c) The Twentyman Playing Field Association T

- Income and bookings continue to be in line with forecast.
- The accounts for the year ended March 2024 have been prepared and accepted by the Management Committee.
- Following the AGM, to be held on 15th May, they will be submitted for audit together with the reports of the AGM.
- The refurbishment is moving ahead with only minor items to be finished within the toilets, plus the complete replacement of all internal and external doors.
